**Tomáš Durdík – MMT Performance is under no circumstances liable for any damages /or for any damages caused by hidden mechanical flaws or defects in connection with the vehicle/ before, during or after the vehicle is/was tested/tuned on Mustang Dynamometer and also is not responsible for any damages before, during or after the vehicle is/was tested/tuned on Mustang Dynamometer on any part of the property /interior or exterior/ where dynamometer is located.**
